Website Project

The new site launched without a hitch, other than me working with Dan Woodman to fix some things prior to and just after the launch. Big thank-you's to Rich Hansen (history) and Doug Ferrier (awards) for helping to proofread portions of the site.

NEXT DATA DOWNLOAD:

If possible, I'd like to have Mike Isely download a file with district quartet member and contact info from BHS in early late August or early September so I can update the website with the current/active quartets.

FASTER NEWS UPDATES:

The admin tools enable me to put news updates and calendar events on the website much more quickly. We can write news updates and schedule them for future dates. We can also have news articles expire on a scheduled date. This was very useful as we promoted that fall convention registration was open. The admin tool broke in late June and it took a while for Magic Blue Box to fix it. It's working again.

EASIER AWARD UPDATES:

Now that the award data feeds from a google sheet to the website, in the future when we have new award winners, we only need to add the new info to the google sheet. It will be faster and easier to keep the site up-to-date.

Social Media

- Throughout the spring, I highlighted all chapter shows I was aware of. I continue to ask chapters to make IL District a co-host of Facebook events so we can promote them.
- Engaged with many posts by chapters and quartets (likes, comments, sharing posts). I worked to highlight all chapter and quartet performances, guest nights, social events that I was aware of especially fabulous performances at international by Sound of Illinois, Linc 182, Lake Shore Drive, After Hours.
- Future (same list as last report, as I took some time off this summer for a vacation, lots of summer boating, and a trip to International contest)

Continue to engage with barbershop-related posts.

Explore getting more involved with Instagram & Tik Tok

Promote the Fall Convention (the dates will be added to the new site as soon as it launches)

OLD BUSINESS

- Fall Convention recap
 - \rightarrow Overall
 - Overall great impressions
 - No significant issues
 - New location for quartet semi-finals (at the church) was terrific
 - Some tweaks for Saturday morning being considered, but nothing major.
 - Consider making the chorus contest start earlier with the convention activities happening in between chorus and quartet competitions will allow choruses to participate more in the convention.
 - Best attended QCA show in years
 - A lot more singing at this convention than in years
 - Need to more formally set the time when the 50 year members are recognized probably at the quartet finals or the president's reception.
 - Put the list in the program as well.

 \rightarrow Notes about future conventions:

- Note correction from last Fall's venue discussion: BCPA is in fact actually cost competitive compared to other possible venues.
- Note also that ISU has their homecoming weekend overlapping our convention for this year but ISU will be looking to October in the future.

BHS Illinois District Board Meeting

- → Financial
 - Per-event ticketing needs to be improved. Will set up a table at the BCPA, in spite of the entanglement of TicketMaster.
 - For Fall 2023, loss of \$2500 (as opposed to \$10000 in prior years). But that's OK because it's part of what the district does and that's why we have dues.
 - Ads were a money loser, however it's because we didn't get the word out soon enough. Lesson learned, let's get this started sooner for 2024. Probably should be a dedicated focus for a single person.
- Website Glenn Mills
 - \rightarrow We're very close. Everything is built and tidying up a few things
 - → Was expecting a launch schedule, got a bill instead. Glenn won't pay the bill until the site is launched.
 - \rightarrow [Note to self, send self-photo to Glenn.]
- Four year plan update
 - \rightarrow Plan to be updated again this summer in order to keep things moving smoothly.
 - \rightarrow Looking to make HCMW break even in 2025.
 - Tim and Dan will be stepping away from HCMW after this year.
 - \rightarrow Regional social events
 - Try to get 1 or 2 social events going this summer.

 - \rightarrow Two candidates in judging program
 - Got one so far (Jeff Lathom)
 - \rightarrow Establish a treble chapter
 - Peoria has a treble chorus forming up
 - → District-wide Harmony-explosion camp
 - Nightmare, not happening any time soon.
 - \rightarrow Combined convention with another district
 - Cardinal is not an option (linked to JAD)
 - CSD Next time they have a convention nearby...
 - LOL probably fatal logistical issues
- District Chapter President's Group
 - \rightarrow Reaching out to chapters now (focusing on those not tightly coupled to the district)
 - \rightarrow Before the end of the month there will be an email sent out.
- Chapter Visit update
 - \rightarrow Need to still visit Lake County (Isely), just need to get of my butt and do it
 - \rightarrow Northbrook still needs to be visited
 - \rightarrow If there is a chapter you visited that you think could benefit from a second visit do it!

- Director class update
 - \rightarrow Theo Hicks was supposed to do our director's class but canceled.
 - \rightarrow Probably would be good to get someone from a nearby district

New Business

- ➢ IDEA
 - \rightarrow Terry and Jim (Waldorf) pledged to IDEA to help them raise \$10K
 - → A program called "IDEA Direct"
 - \rightarrow Mechanism is periodic ACH transfers or credit card posts
 - \rightarrow Will generate tax letters for those making donations
 - → It's important for IDEA to become more visible and to give away at least 5% of the assets every year.
 - \rightarrow Looking for Board members to sign up "lead by example".
 - → If this generates an influx of huge numbers of donations, can IDEA's internal processes handle this? (Sure it's a good problem to have...)
- > Funding for quartets and choruses for International
 - → Current funding structure really isn't enough to cover a quartet's registrations. In the (distant) past, the funding was supposed to cover registrations, but that's back when it was scale of \$100. Do we update this?
 - \rightarrow The district is smaller now; we don't have the budgets we used to
 - \rightarrow IDEA has it written in their by-laws that they should be supporting quartets for International.
 - \rightarrow We need to get the word out about IDEA.
 - → What about a district funded show, with profits going to the quartets. Similarities to the old CABC shows.
 - \rightarrow Table this for now; must be resolved before the next budget.
- HCMW status (this weekend)
 - \rightarrow Over 100 attendees.
 - \rightarrow All 10 quartet spots filled.
 - \rightarrow Prices somewhat higher this year.
 - \rightarrow Bottom line is expected to be similar to last year.
 - \rightarrow Only 6 or 7 (out of 10) IDEA scholarships have been mapped.
- District Dues
 - \rightarrow Should we consider a change? Raise? Lower?
 - → Terry suggests dropping the dues by \$5. We have a good buffer, maybe we as a district can do something to show that we are sensitive to price increases (by BHS).
 - \rightarrow Suggest a drop of \$10 for 2 years, with an automatic restoration unless otherwise done.
 - → What about lowering convention registration? A \$10 drop there will have a lower impact and it may help to encourage attendance
 - \rightarrow Last time this was discussed, the HOD leaned more towards dues changes over convention

- Midwinter Meetings recap
 - \rightarrow Discussion about having Midwinter in NYC conclusion is that this is absolutely "stupid".
 - \rightarrow DPC working on a number of things
 - "Value exchange program" DPC, Harmony Hall, and Society staff work together
 - Revisit the dues structure???
 - Communication issues with the Society (are poor...)
 - Joe Cerutti "Barbershop Expert Network"
 - Online network where anybody in the society can put there name and skills as a resource to be available to others

 - \rightarrow Let's set up a Google Calendar for the district, damnit
